

DESCRIPTION

The first fully renovated house comprises on the ground floor: a large living room with fireplace $(100m^2)$, an open kitchen $(14m^2)$ open to a dining room $(19 m^2)$, a kitchenette $(6.5m^2)$, a master bedroom with its shower room $(17.50m^2 + 7m^2)$, a toilet $(5m^2)$, a laundry room $(7.5m^2)$, a dressing room/linen room $(21m^2)$, a boiler room $(20m^2)$, other outbuildings $(45.50m^2)$. The first floor consists of three bedrooms $(13m^2, 17m^2 \text{ and } 13.50m^2)$ and a master suite (bedroom, dressing room, bathroom $(21m^2)$. A staircase in the living room leads to a mezzanine which is used as an office. A hangar adjoining the house of 188 m² can accommodate vehicles and motorhomes.

The second house is to be refreshed and consists of a kitchen $(6.30m^2)$, a dining room with fireplace $(30m^2)$, a room $(5m^2)$, a living room $(13.50m^2)$, two bedrooms $(10.50m^2 \text{ and } 20m^2)$, a bathroom $(5m^2)$, a toilet $(1m^2)$. A $38m^2$ garage and outbuildings are adjoining.

A swimming pool and its 44m² pool house (with covered terrace, sanitary facilities and technical room) complete the property.
