The restaurant seats approximately 60 in a modern, industrial style decorated dining room. Outside, the terrace with breathtaking views of the Parc de la Vanoise, overlooking the Arc river, can accommodate up to 40 diners. The restaurant holds an unrestricted alcohol license (license IV).

With car parks, the tourist office and all the shops nearby, this pizzeria is also accessible by public transport and, thanks to its location, benefits from a thriving winter and summer tourist season as well as a well-established local clientele.

The commercial lease for the 100m² commercial space, 100 m² 4-bedroom apartment, 40 m² studio apartment, garage, caves and storage space in a co-owned building was renewed in 2022 for 9 years. No staff to be taken over.
