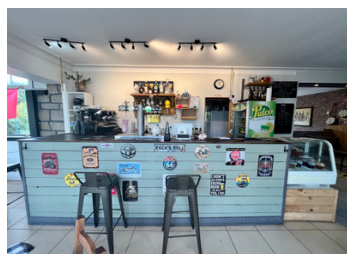

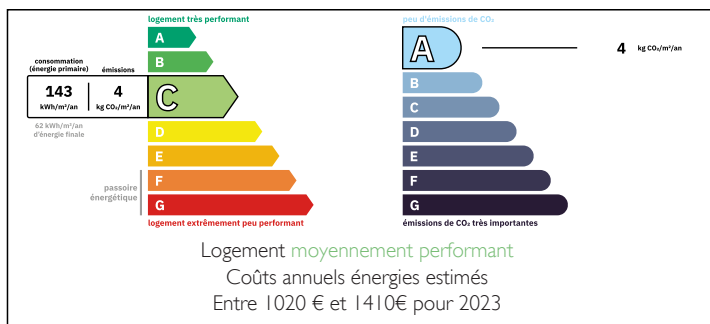

Included with the business is spacious owner's accommodation comprising four bedrooms, a living room and bathroom. The premises benefit from a Licence IV (held by the mairie) and a Petite Licence Restaurant. A fantastic lifestyle business with excellent potential for further development in a welcoming Breton village.

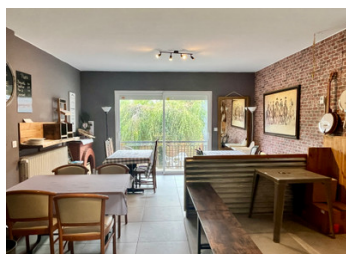
There may also be an opportunity to take on the management of the communal campsite, subject to agreement with the mairie.

DESCRIPTION

Located in the heart of the friendly village of Langoëlan, this is an excellent opportunity to acquire the fonds de commerce of a thriving village bar with food service, a bread depot and spacious owner's accommodation.

Created and developed by the current owner, the business has quickly become a popular meeting place for local residents and visitors alike. Alongside the licensed bar, the owner has successfully introduced food service, popular pizza evenings and live music events, creating a welcoming community hub with excellent potential for further growth.

The premises offer seating for approximately 30 customers inside and a further 24 covers on the sunny terrace, with the added benefit of a garden to the rear, providing additional outdoor space and future possibilities for events or customer enjoyment.

The village bread depot generates regular daily footfall, while the current opening hours offer scope for a new owner to expand the business if desired.

Included with the business is generous owner's accommodation comprising four bedrooms, a living room and a bathroom. The kitchen is shared with the bar, allowing the current food operation to be run efficiently from the premises.

The premises are owned by the local mairie. The business benefits from a 4th category on-premises drinks licence (Licence IV), held by the mairie, together with a Petite Licence Restaurant, allowing the continuation of both bar and food service activities. The future operator will enter into a commercial lease with the mairie, subject to the agreed terms.
